ARx Zinc 9% is a fully chelated stable formulation of zinc which has low use rates and excellent compatibility with liquid fertilizers containing polyphosphates and orthophosphates. ARx Zinc 9% is recommended for the prevention and correction of nutrient deficiency in crops.

FIRST AID

USE RATE

For soil applications in field and row crops or vegetables, add 1 - 2 quarts per acre. For foliar applications in field and row crops or vegetables, add 1 - 2 pints per acre. Add to fertilizer or mix with water.

STORAGE AND DISPOSAL

Storage: Store in cool, dry, well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Keep containers tightly closed when not in use. Do not store in aluminum, mild steel, or brass containers.

Disposal: Do not reuse container. Do not contaminate water, food, or feed by storage or disposal. Triple rinse (or equivalent) container, then offer for recycling at an ACRC site (go to <http://www.agrecycling.org/>) or dispose of empty containers in accordance with local, state, and federal regulations.
